### FORMS NEEDED & ORDER IN WHICH PACKETS SHOULD BE ARRANGED WHEN SENT TO SETS:

#### INDIVIDUALIZED EDUCATION PROGRAM (IEP) PACKETS

- Form 16 Whatever is listed under SDI needs a Form 12 & 13 to match; IEP meeting date **must match** form 9 meeting date. Start date should match meeting date.
- Form 17 Program placement and if student is on a shortened day, document that on this page.
- Form 18 You need 4 signatures: Parent, Advisor, Dist.Rep., & Gen.Ed.Teacher.  
*Remember* – you **must** have **Parent** also sign in **Consent** section on **Initial** IEP's.
- Transition Plan (3 pgs) Needed for students age 16 and older.
- Form 12 Need to match the SDI (subjects) you list on form 16.
- Form 13 Goal & objectives for each area of SDI shown on each form 12.
- Form 15 Needed for grades K-10.
- Form 9 Final mtg. date must match IEP mtg. date on form 16.
- Form 10 Prior Written Notice

#### AMENDMENT PACKET

- Form 19 With 4 signatures (same rule applies as IEP form 18)
- Form 16 (Optional)
- Form 9 Final meeting date must match "Date of this Amendment" on form 19.
- Form 10 With Proposing to change IEP boxes selected.

#### AMENDMENT PACKET WITHOUT RECONVENING

- Form 20 With required signatures
- Form 10 With Proposing to change IEP boxes selected.
