

**INVITATION TO BID**  
**FOSS HIGH SCHOOL FACILITY UPGRADES**

Notice is hereby given that sealed bids will be received via electronic bidding on [Bonfirehub](#) at the Tacoma School District Procurement Portal for the Foss High School Facility Upgrade project. Base Bids and Alternate Bids will be received on Form of Bid until **2:00 PM on May 25, 2021** stamped in and held. Bids will be reviewed, verified, read out loud by the Tacoma Public Schools Purchasing Department and results will be posted on the Bonfire Portal.

When registering on the Bonfire website, follow instructions and use at least one or any combination of the following classification / commodity codes, as applicable for your firm: 906-10, 906-25, 958-26, 906-38, 925-44, 909-21, 909-22, 909-24, 909-27, 909-31 and / or 912-38.

Estimated construction cost, including alternate bids: \$1,200,000.00.

A pre-bid meeting and site walk-through (following COVID safety guidelines) will be held at **10:00 A.M., Wednesday, May 5, 2021, at Foss High School, 2112 South Tyler Street, Tacoma Washington 98405**, beginning outside of the school's main office in the main plaza. Another meeting may be scheduled, later the same day, if there are too many people schedule for the first site walk-through. We will review the scope of the work and the documents and provide site specific information applicable to the project. Attendance to this walk-through is strongly suggested. A sign-in sheet will be provided and included in a subsequent addendum.

Deadline for questions submitted to the Bonfire Hub is May 13, 2021, 2:00 P.M. PST.

Prospective Bidders who are intending to submit a bid shall complete the intent to submit in Bonfire by no later than May 13, 2021. **This is required to be completed in Bonfire to be considered a responsive bidder.**

The Tacoma School District reserves the right to reject any and all bids and to waive any irregularities or informalities. The right is reserved by the Tacoma School District to postpone contract award for the period of thirty (30) days after the bid opening. The Tacoma School District is an Equal Opportunity Employer. No bidder may withdraw the bid after the hour set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding thirty (30) days.
